

PUBLIC OFFER

OF THE CHARITY DONATION AGREEMENT

This offer (hereinafter referred to as the "Agreement") is deemed to be a public contract pursuant to Article 396 of the Civil Code of the Kyrgyz Republic and is an offer by the Sun of Hope Public Fund (hereinafter referred to as the Fund), by accepting and agreeing to the terms and conditions set out in this Agreement, to provide the opportunity to make voluntary payments (donations) for the benefit of the Fund.

1. General Provisions

1.1 This Agreement governs the procedure and conditions for payments in favour of the Fund in the form of cash and non-cash payments, including but not limited to internet canvassing, electronic payments, and payments from a mobile phone credit.

1.2. The Foundation shall have the right to enter into donation agreements with reference to the Offer in a manner different from that provided for in this Offer. The meaning and application of the Offer shall be determined by the terms of such agreements.

1.3. The Fund shall have the right to enter into the donation agreements in a different manner and (or) on different terms than those provided for in the Offer, for which any interested person shall have the right to apply to the Fund.

2. Subject matter of the agreement. Acceptance of the Offer

2.1 In accordance with this Agreement, the Donor shall transfer funds as a voluntary donation to the Foundation's clearing account.

2.2. Acceptance of this offer is the transfer of funds by the donor to the account of the Fund, its paying agent, and the transfer of funds to the receiving bank as a voluntary donation for statutory activities or for other purposes.

2.3. Acceptance of this offer by the Donor means that the donor, as a fully capable and legal person has read and agrees to all the terms and conditions of this agreement.

2.4. The Offer may be accepted by the Donor by any of the following:

2.4.1. By transfer of funds by the Donor by money order to the Fund's details, using payment terminals, credit cards, electronic payment systems and other electronic services.

2.4.2. By placing cash in donation boxes established by the Foundation or third parties acting on behalf and in the interests of the Foundation.

2.5. The donor is deemed to have accepted the terms of this offer, regardless of the results of banking transactions, after completing the required payment forms and giving their consent on the website.

3. Procedure for donations

3.1 The donor independently transfers funds free of charge for the implementation of the Fund's programmes.

3.2 The Donor independently determines the voluntary donation amount and transfers it to the Fund's bank account in the manner indicated on the Fund's website.

3.3. When transferring a donation, the donor may provide his/her contacts for correct identification of the payer: e-mail address, and telephone number.

3.4. By accepting this Offer, the Donor agrees to receive information and communications from the Fund to the telephone number provided by the User, by e-mail or through information and communication services. The Donor may revoke this agreement by sending a letter in any form to the official e-mail of the Foundation.

3.5. The Fund is not responsible for technical failures when receiving non-cash donations through no fault of its own.

4. Consent to the processing of personal data.

4.1. in order to achieve the objectives of this agreement, the Donor confirms his consent to the processing by the Fund of his personal data (full name, address, place of residence, e-mail address, bank details and others), which he provided when making the deposit, including the collection, recording, systematization, accumulation, storage, clarification (updating, modification), extraction, use, transmission (distribution, provision, access), depersonalization, blocking, deletion, destruction of personal data.

4.2. the Donor confirms his/her consent to the transfer of personal data for processing by third parties in order to fulfil this agreement, as well as for the settlement of claims related to the execution of this agreement.

4.3. In all other cases, the Fund undertakes not to disclose the Donor's personal data to third parties without the Donor's written consent. An exception to this is the request for information by governmental bodies authorized to require such information.

4.4. Consent to the processing of personal data is valid until the donor revokes it in writing.

4.5. the refusal to process personal data can be made by sending a request in any form to the official e-mail address of the Fund or by filling in feedback forms on the website <https://sunofhope.fund>.

5. Rights and obligations of the parties.

5.1. The Fund undertakes to use the funds received from the Donor under this Agreement within the framework of its statutory activities strictly in accordance with the applicable legislation of the Kyrgyz Republic.

5.2. The Donor has the right to choose the object of support at his own discretion by specifying the relevant purpose of payment when transferring the donation. The list of programs and information about those in need will be published on the website <https://sunofhope.fund>.

5.3 If no purpose is indicated, the donation shall be used for activities of the Foundation in accordance with its statutes.

5.4. The Donor has the right to receive information about the use of the donation. To exercise this right, the Foundation publishes on the website <https://sunofhope.fund> information on the amounts of donations, and a report on the use of donations, at the Donor's request, the Foundation is obliged to confirm the intended use of donations received.

6. The procedure for changing the offer. Final clauses

6.1 The offer comes into force from the moment of its publication on the Internet on the site <https://sunofhope.fund> and is unlimited in time.

6.2. The Fund may amend the text of the present offer without prior notice. The amendments shall be effective from the day following their publication on the website.

6.3. In matters not specified in this Agreement, the Parties are responsible for the proper performance of their obligations in accordance with the legislation of the Kyrgyz Republic
